Ofqual Qualifications

Options available;
Open Public, Onsite and E-Learning

HABC L2 Combined (Hot/Cold Water Systems + Cooling Towers)

Ofqual accredited course designed to help delegates with a basic knowledge of ACoP L8 and HSG 274 documents and expected standards of water-borne bacteria that causes Legionnaires' Disease.

HABC L3 Legionella Control for Responsible Person

Ofqual accredited level 3 includes essential knowledge around Legionnaires' Disease and how to manage a written Legionella control scheme and risk assessment process.

HABC L2 Legionella (Hot/Cold Water Systems)

Ofqual accredited level 2 for those managing hot / cold water systems designed to minimise risk of water-borne bacteria and comply day-to-day with ACoP L8.

HABC L2 Legionella (Cooling Towers & Evaporative Condensers)

Ofqual accredited level 2 for those managing cooling towers and/or evaporative condensers.

City & Guilds Qualifications

City & Guilds Role of Responsible Person

This course is aimed at those staff involved in the management of building water systems, particularly those individuals who have been nominated as the Responsible or Appointed Person.

City & Guilds Safewater in Healthcare Premises HTM04-01

This course is aimed at those staff involved in the management of building water systems in Healthcare facilities and particularly those in operational management.

City & Guilds Legionella Awareness Hot and Cold Water Systems

This course is aimed at those staff involved in monitoring and managing hot and cold water systems to ensure the risk presented by legionella bacteria is minimised.

City & Guilds Legionella Awareness & Risk Management

This course is aimed at anyone involved in the management and operation of water systems to ensure the risk presented by legionella bacteria is minimised.

City & Guilds Legionella Awareness Cooling Towers & Evaporative Condensers

This course is aimed at those staff involved in monitoring and managing cooling towers and/or evaporative condensers to ensure the risk presented by legionella bacteria is minimised.

City & Guilds Legionella Control in Spa Pool and Associated Management Systems

The course is aimed at maintaining clean, clear, safe water quality and hygiene in accordance with Regulations and UK guidelines. It includes a reminder about chlorine, chlorinated isocyanurates, salt chlorination, ionisation, ozone generation, bromine-based disinfectants and UV disinfection.
